Dear Parent,

The Bow School District has contracted with ***Attitudes Driving School (603) 783-0191*** to provide a high school driver education program. In order for our program to be successful, it is essential that we have close cooperation of parents and guardians for our driver trainees. Our goal as certified instructors is to develop better defensive drivers, and to improve the behavior and performance of our highway users.

The course consists of 30 hours of classroom study, 10 hours behind-the-wheel instruction, and 6 hours of observation time. In addition to this instruction, the State of New Hampshire requires that each student obtain at least 40 hours (30 day, 10 night hours) of behind-the-wheel practice at home under the guidance of an adult age 25 or older, who holds a valid license. The driver trainee must be at least 15 ½ years old. It would be advisable that you inform your insurance company that your driver trainee is practicing on the family car. Students must be 16 by the last classroom session.

The cost of the course is **\$675.00**. The consent form attached to this letter is to be signed by either a parent or legal guardian stating that your son/daughter may participate in the program. Please detach and return the signed slip as soon as possible.

Students wishing to participate in the Driver Education Program will be selected on a first come, first serve basis. There will be a \$40.00 charge if a student misses a scheduled driving appointment without a 5 hour advance notice to their instructor.

There are no refunds after the student or parent has confirmed the student is taking the course, either by *Attitudes Driving School* or the *Bow School District*. If a student is dropped from the Driver Ed Program or a student chooses to drop out, a new application must be filed out and the complete Driver Ed fee paid again. This is an 8 week commitment. If the student will miss more than 2 class sessions (for good cause) they should not sign up for this program. At the end of the course, you will receive an evaluation of your driver trainee's progress.
